I, the Personal Data Subject, hereby, in accordance with Federal Law No. 152-FZ of 27 July 2006 "On Personal Data" and Federal Law No. 38-FZ of 13 March 2006 "On Advertising", freely, of my own will and in my own interest, give my consent to LLC "TRADING COMPANY KOBLIK" (hereinafter — the Operator) to process my personal data and to receive advertising and informational materials on the following terms:

1. Purposes of Personal Data Processing

- Push notifications;
- Messages in social networks (VKontakte, Odnoklassniki) and messengers (WhatsApp, Telegram);
- Telephone calls (where the number has been confirmed).

4. Validity Period of the Consent

- The consent is valid indefinitely until it is withdrawn by the Personal Data Subject.

5. Confirmation of Consent

- Any of the following actions shall be deemed confirmation of consent:
- Clicking the "Subscribe", "Send" or similar button;
- Ticking the "✓" or "•" box in a form on the Site.

These actions constitute sufficient evidence of the Subject's free expression of will.

6. Terms of Data Processing and Transfer

Processing is carried out by automated and non-automated means;

Transfer to third parties (telecom operators, advertising services) is permitted solely for the purposes specified in clause 1;

Special categories of personal data and biometric data are not processed.

7. Rights of the Subject

To withdraw consent via the "Unsubscribe" link in any message;

To send a withdrawal request to the email address sales@koblik.com with the note "Refusal of mailings";

To request information regarding the processing of data by applying to the Operator.

8. Confirmation of Actions

By using the Site and performing the actions specified in clause 5, I confirm:

That I have read the Personal Data Processing Policy;

My consent to the use of tracking technologies (cookies, pixels) for behavioural analysis.
